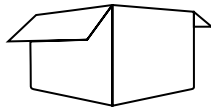

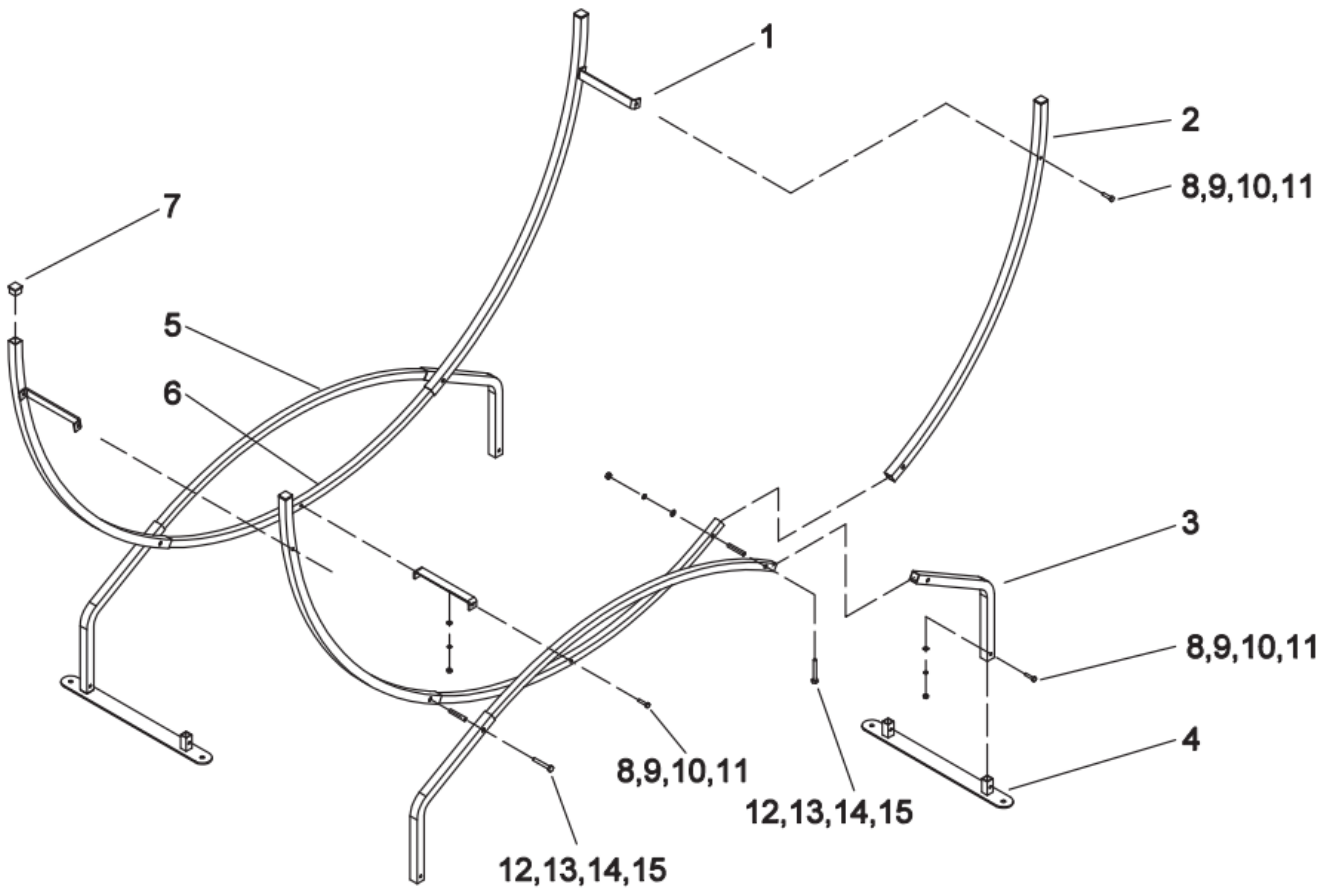
8' Crescent Firewood Rack





UNBOXING

- 1.** SUPPORT BLOCK (3 PC)
- 2.** SIDE TUBE (4 PC)
- 3.** FOOT TUBE (4 PC)
- 4.** FIXED PLATE (2 PC)
- 5.** INTERMEDIATE TUBE (2 PC)
- 6.** PERFORATED MIDDLE TUBE (2 PC)
- 7.** BULKHEAD (4 PC)
- 8.** BOLT M8X50 (10 PC)
- 9.** 8 WASHER (10 PC)
- 10.** 8 SPRING WASHER (10 PC)
- 11.** M8 NUT (10 PC)
- 12.** BOLT M10X75 (4 PC)
- 13.** 10 WASHER (4 PC)
- 14.** 10 SPRING WASHER (4 PC)
- 15.** M10 NUT (4 PC)



STEP 1

Slide short side of Legs (part 1) onto the Feet (part 2). Align holes, insert Short Bolt, and attach with Washer, Spring Washer, and Nut (part 4).

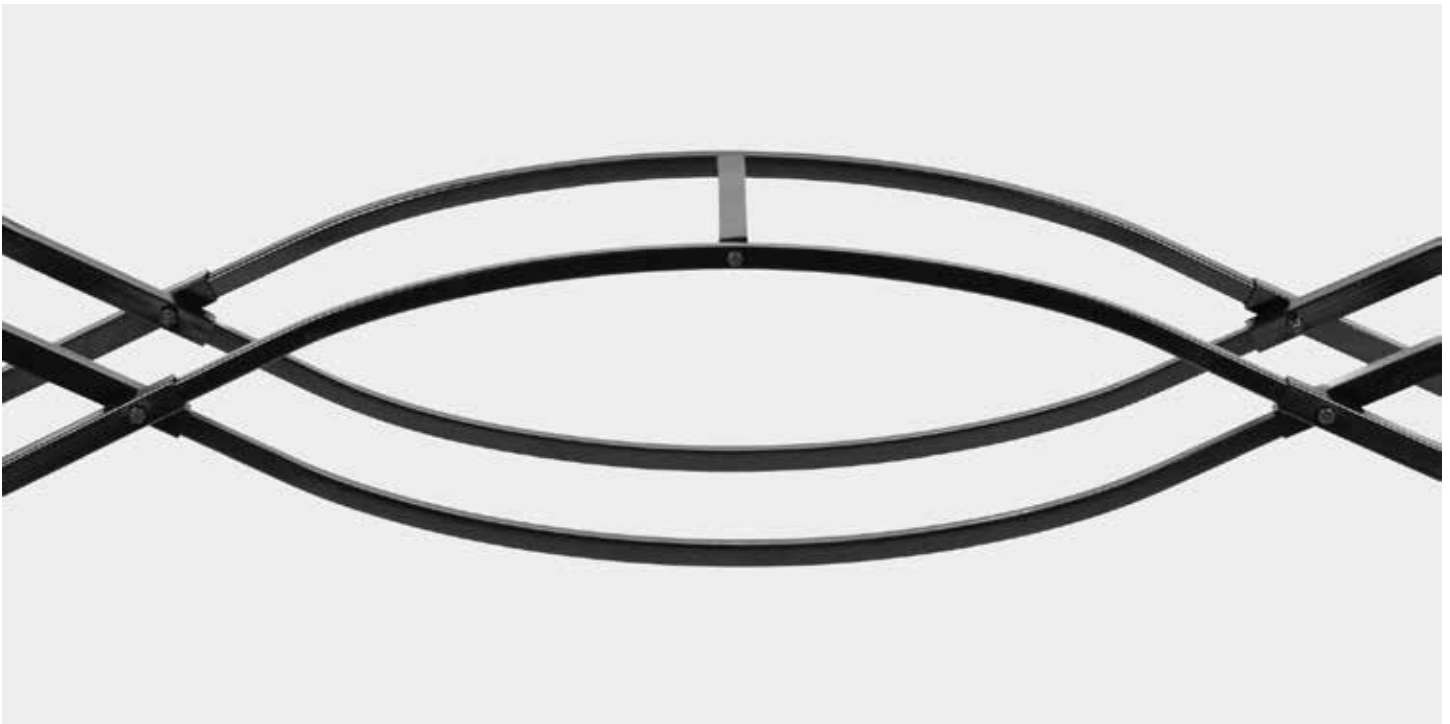


STEP 2

Slide Upper Tubes (part 6) into Legs (part 1). DO NOT BOLT IN YET!

STEP 3

Slide 2 Side-Wall Tubes (part 7) into each Lower Tube (part 5). DO NOT BOLT TOGETHER YET! This step should result in 2 large U-shaped crescents.



STEP 4

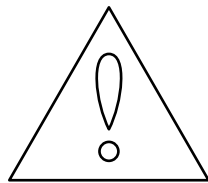
Bolt each U-shaped crescent to the INSIDE of your base using the Long Bolt (part 3) secured with the washer, spring washer, and nut. Hand tightens only!

STEP 5

Bolt in the 3 Support Brackets (part 8) using the Short Bolts (part 4) secured with the washers, spring washers, and nuts. Tighten down fully using a wrench.

STEP 6

Once you have ensured all tubes are seated and aligned properly, go back, and tighten all remaining bolts with a wrench. Be careful not to over-tighten as this could damage the tubing.
